**Call to Order**

The meeting was called to order by the chairman at 7:32 p.m.

**Approval of November 21, 2023, Meeting Minutes**

**Old and New Business**

- a.) **John Sabetta, 1256 Chase Parkway, Waterbury, regarding sewer connection to Middlebury sewer system.**

Mr. Sabetta is in the process of selling his home. The septic is failing. He has two neighbors on Reynolds Rd in Middlebury. He is looking to connect. Chairman Smith stated they had Mr. Angeri look into this and Mr. Sabetta would have to have permission from both neighbors to tie into the two-inch force main. He will have to have permission from Waterbury to abandon the existing septic system he

currently has. He will have to pay an assessment charge and be responsible for his own connection costs. A letter will be sent out to Mr. Sabetta with the full list of conditions. Chairman Smith **MOTIONED** to approve pending the completion of the requirements Mike Angeri set forth, **SECONDED** by Mark Petrucci.

**b.) WPCA Budget F.Y. 2024-2025, 2<sup>nd</sup> Draft.**

Chairman Robert Smith said he got a full breakdown of the budget, and it is going up \$4,000.00. Chairman Smith asked if there were any questions and there were none from the members. Chairman Smith **MOTIONED** to approve Ted Manello **SECONDED**. Unanimous approval.
